GENERAL CONDITIONS OF SALE OF CONFERENCE SPACE

Virtual conferences are accessible via live streaming on the official Rendez-Vous de Septembre website (<https://www.rvs-monte-carlo.com>) and will be recorded for future viewing.

Any order booking made for conference and workshop means agreement of these general conditions of sale

ORDER

Art. 1: Any order for services placed by a client must take the form of an order form supplied by URIEL EVENTS, which represents a binding legal and financial commitment made by the partner.

Client orders must be accompanied by the corresponding payment or by evidence of payment of the total sum due.

Art. 2: URIEL EVENTS will confirm validation of the order within eight working days from reception of the order form.

In the absence of payment, URIEL EVENTS reserves the right not to execute the requested order. The client accepts sole liability for the consequences that may result from delayed regularization of the situation.

Art. 3: The order will be executed according to the information provided by the client on the order form, provided these are consistent with good professional practices. URIEL EVENTS reserves the right not to execute the requested order according to the conditions requested by the client if they are not in conformity with applicable regulations. If such a situation arises, URIEL EVENTS shall inform the client and the order shall be suspended until additional information is received and the client accepts the necessary modifications.

In addition, if on the occasion of a previous order the client had failed to observe any of these obligations, by not paying on time for example, this client's order could be refused unless satisfactory guarantees are provided or payment is made in advance.

Art. 4: Any request for modification or cancellation of the order should be made to URIEL EVENTS within the time limit indicated on the order form. Modifications to the order form will be accepted by URIEL EVENTS subject to their feasibility.

Any modification that does not lead to the cancellation of one or several articles ordered is considered to be a modification to the order form.

Requests will be processed according to date of reception and availability.

REQUESTS FOR RESERVATION
