



## **RENDEZ-VOUS DE SEPTEMBRE PRIVACY POLICY**

**(HEREINAFTER « RVS »)**

### **ARTICLE 1 : PREAMBLE**

This privacy policy applies to the website [www.rvs-monte-carlo.com](http://www.rvs-monte-carlo.com) and to the RVS mobile and web application (hereinafter « the Application »). Its purpose is to inform users about the conditions under which RVS collects, processes, stores and protects their personal data.

RVS, an association governed by Monegasque law, undertakes to process your data in accordance with Monegasque Law No. 1.565 of 3 December 2024, on the protection of personal data and, where applicable, Regulation (UE) 2016/679 (GDPR).

This document provides a comprehensive description of the categories of data processed, the purposes of the processing, the rights available to users, the procedures for exercising those rights, and the obligations of the data controller and processors.

By using the website or application, users acknowledge that they have read this policy and accept its terms.

### **ARTICLE 2 : GENERAL PRINCIPLES GOVERNING THE COLLECTION AND PROCESSING OF DATA**

In accordance with the provisions of Article 5 of European Regulation 2016/679, the collection and processing of data from users of the site complies with the following principles:

- Lawfulness, fairness, and transparency: data is collected and processed on a legal basis (including consent, performance of a contract, legal obligation, or legitimate interest, as applicable). Whenever personal data is collected, the user is informed of the data concerned and the purposes of the processing;
- Limited purposes: data is collected and processed to meet one or more objectives specified in these general terms and conditions of use;
- Minimization of data collection and processing: only data necessary for the proper execution of the objectives pursued by the site is collected;



- Limited data retention period: data is retained for a limited period, of which the user is informed. When this information cannot be communicated, the user is informed of the criteria used to determine the retention period.
- Integrity and confidentiality of data collected and processed: the data controller undertakes to guarantee the integrity and confidentiality of the data collected.

In order to be lawful, and in accordance with the requirements of Article 6 of European Regulation 2016/679, the collection and processing of personal data may only take place if it complies with at least one of the conditions listed below:

- The user has expressly consented to the processing;
- The processing is necessary for the proper performance of a contract;
- The processing is necessary for compliance with a legal obligation;
- The processing is necessary in order to protect the vital interests of the data subject or of another natural person;
- The processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority;
- The processing and collection of personal data is necessary for the purposes of the legitimate and private interests pursued by the data controller or by a third party.

### **ARTICLE 3 : PERSONAL DATA COLLECTED**

#### ***A. DATA COLLECTED***

The personal data collected is as follows:

- IP address ;
- Title ;
- Last name ;
- First name ;
- Company ;
- Personal and/or company email address ;
- Personal and/or company postal address
- Personal and/or company landline telephone number ;



- Personal and/or company mobile telephone number ;
- Position in the company ;
- Language of communication ;
- Press card number and image ;
- Photograph of registered persons ;
- Hotel/location and dates of stay of the registered person ;
- Bank or payment Information ;
- Number of years of participation ;
- Hotel and location preferences ;
- Level of quality of stay.

This data is collected when the user performs one of the following operations on the site :

- Creation of a login account: This account gives access to both the site and the application ;
- Registration for the conference, individual and/or company ;
- Reservation of accommodation and other options, such as registration for conferences, round tables, use of the agenda, for example ;
- Purchase and payment of one or more products ;
- Signing up for informational emails.

In addition, when a payment is made on the website, proof of the transaction, including the order form and invoice, will be stored in the website publisher's computer systems.

The data controller will store all data in the website's computer systems under reasonable security conditions. The data will be kept for the entire period of participation plus 5 years. This is necessary due to recurring participation, as it provides access to levels of quality of stay and services based on the number of years of participation.

The collection and processing of data serves the following purposes :

- You decide to continue browsing the rvs-monte-carlo.com website (cookies) ;
- You request to subscribe to email alerts or send us an email ;
- Registration of one or more participants and/or companies ;



- Reservation, confirmation, or cancellation of accommodation or transport ;
- Communication practical information before, during, and after the conference ;
- Management of admissions to the conference venue ;
- Management of appointment schedules and availability ;
- Purchases and payment for services by the user ;
- Invoicing and payment of any amounts due ;
- Management of privileges acquired based on seniority.

Data Processing is based on the following legal grounds :

- Consent ;
- Performance of a contract ;
- Legitimate interest.

## *B. USE OF DATA AND ACCOUNT FUNCTIONALITIES*

### a. User account

To access the site and the Application, the user must use their account.

Users may choose to make certain data invisible in the list of participants.

The RVS Application collects additional data related to its operation and interactions between participants. This data varies depending on the features enabled.

### b. Push notifications

The Application may send push notifications. For this purpose, a specific technical token (push token) is stored. Users can disable notifications in their device settings.

### c. Chat function

Users can exchange messages with other participants. Sent and received messages are stored in the backend system and on the devices of the participants for as long as necessary for the purpose of the service.

### d. List of participants

Participants who have created an account appear in the official contact list, unless they have exercised their right to object. Users can contact other participants by email or chat. Favorites are stored only on the user's device.



e. Geolocation during the event

When the feature is enabled, the Application may collect the user's approximate location in order to improve certain services. This data is not stored.

*C. TRANSMISSION OF DATA TO THIRD PARTIES*

Data may be transmitted to the third parties listed below :

- To hotels and accommodation providers and any third-party tourism and transport service providers when necessary in order to book, confirm, modify, cancel, and receive participants at these locations, as well as to manage the RVS in conference and meeting rooms, organize transport, and when the transmission of this data is necessary for the smooth running of the stay and the conference ;
- To logistical or technical partners involved in the organization of the conference ;
- To sponsors or financial partners when their involvement requires data processing ;
- To Monaco Télécom, which hosts certain data ;
- To SYSELIO, the service provider responsible for developing the website and the Application, as well as managing the backend and the Content Management System :

#### **ARTICLE 4 : THE DATA CONTROLLER**

##### *A. THE DATA CONTROLLER*

The controller of personal data is :

The data controller is responsible for determining the purposes and means of processing personal data.

##### *B. OBLIGATIONS OF THE DATA CONTROLLER*

The data controller undertakes to protect the personal data collected, not to pass it on to third parties without the user's knowledge, and to respect the purposes for which the data was collected.



The site has an SSL certificate to ensure that the information and data transfer via the site is secure.

An SSL ("Secure Socket Layer") certificate is designed to secure the data exchanged between the user and the site.

In addition, the data controller undertakes to notify the user in the event of rectification or deletion of data, unless this entails disproportionate formalities, costs, and procedures for the data controller.

In the event that the integrity, confidentiality, or security of the user's personal data is compromised, the data controller undertakes to inform the user by any means.

The data generated by the Application is kept for the time necessary to organize and monitor the event, then archived and/or deleted according to the applicable retention periods and within a maximum period of one year.

## **ARTICLE 5 : USER RIGHTS**

In accordance with the regulations concerning the processing of personal data, the user has the rights listed below.

In order for the data controller to comply with their request, users are required to provide their first and last names, email address, and, if relevant, their account number or personal space or subscriber number.

The data controller is required to respond to the user within a maximum of 30 (thirty) days.

### *A. OVERVIEW OF USER RIGHTS REGARDING DATA COLLECTION AND PROCESSING:*

#### **a. Right of access, rectification and erasure**

The user may view, update, modify, or request the deletion of data concerning them, in accordance with the procedure set out below:

#### **b. Right to data portability**

The user has the right to request the portability of their personal data held by the site to another site, in accordance with the procedure set out below:

#### **c. Right to restriction and objection to data processing**

Users have the right to request the restriction or object to the processing of their data by the website, without the website being able to refuse, unless it can demonstrate the existence of



legitimate and compelling reasons that may override the interests and rights and freedoms of the user.

d. Right not to be subject to a decision based solely on automated processing

In accordance with the provisions of Regulation 2016/679, users have the right not to be subject to a decision based solely on automated processing if the decision produces legal effects concerning them or similarly significantly affects them.

e. Right to determine the fate of data after death

Users are reminded that they may organize what should happen to their collected and processed data if they die, in accordance with applicable regulations.

f. Right to refer the matter to the competent supervisory authority

If the data controller decides not to respond to the user's request, and the user wishes to contest this decision, or if they believe that one of the rights listed above has been infringed, they are entitled to refer the matter to the Personal Data Protection Authority (APDP) (Monaco) and/or any competent judge. ## ***B. PERSONAL DATA OF MINORS***

In accordance with the provisions of Article 8 of European Regulation 2016/679 and the French Data Protection Act, only minors aged 15 or over may consent to the processing of their personal data.

If the user is a minor under the age of 15, the consent of a legal representative will be required in order for personal data to be collected and processed.

The website publisher reserves the right to verify by any means that the user is over the age of 15, or that they have obtained the consent of a legal representative before browsing the website.

## **ARTICLE 6 : USE OF “COOKIES”**

The site may use “cookies”.

A “cookie” is a small file stored by the site on the user's device containing information about the user's browsing habits.





These files enable the website to process statistics and traffic information, facilitate browsing, and improve the service for the user's convenience.

For the use of cookies involving the storage and analysis of personal data, the user's consent is required.

This consent is considered valid for a maximum period of 6 (six) months. At the end of this period, the site will again request the user's authorization to save cookies on their hard drive.

a. User opposition to the use of cookies by the site

Cookies that are not essential to the functioning of the site are only placed on the user's terminal after obtaining their consent. The user may withdraw their consent at any time, as follows:

**Non-applicable - No non-essential third-party cookies are used.**

More generally, users are informed that they may oppose the storage of these cookies by configuring their browser software.

If the user decides to disable cookies, they will still be able to browse the site. However, any malfunction of the site caused by this disabling cannot be considered to be the fault of the site publisher.



b. Description of cookies used by the website

The website publisher draws the user's attention to the fact that the following cookies are used when browsing:

- *DonCultureCd* : Stores the selected display language.  
Used exclusively for the proper functioning of the website  
Website publisher cookie
- *ASPXAUTH* : User ID for the session in the site's participant interface.  
Used exclusively for the proper functioning of the site.  
Website publisher cookie
- *ASP.NET\_SessionId* - User ID for the session on the public site.  
Used exclusively for the proper functioning of the site.  
Website publisher cookie

In addition, the site includes social media buttons, allowing users to share their activity on the site. Cookies from these social media sites may therefore be stored on the user's computer when they use these features.

Users should note that these sites have their own privacy policies and terms and conditions of use, which may differ from those of the site. The site publisher invites users to consult the privacy policies and terms and conditions of use of these sites.
